DAURIL ALDEN received his PhD from the University of California, Berkeley in 1959. He is currently a professor in the Department of History at the University of Washington, where he specializes in the history of Colonial Latin America. Recent publications include: *Charles R. Boxer: An Uncommon Life. Soldier, Historian, Teacher, Collector, Traveler* (Lisbon: Fundação Oriente, 2001); *The Making of an Enterprise: The Role of the Jesuits in Portugal, its Empire, and Beyond, 1540-1750* (Stanford UP, 1996); and, "God's Share of the King's? The Jesuits and the Payment of Tithes in Colonial Brazil," *Colonial Latin American Review* (I.1-2, 1992).

THOMAS COHEN is curator of the Oliveira Lima Library and associate professor of history at the Catholic University of America. He is the author of *The Fire of Tongues: António Vieira and the Missionary Church in Brazil and Portugal* (Stanford UP, 1998), and is currently working on a book about New Christians, Jews, and Judaism in the early modern Portuguese world.

FRANCIS A. DUTRA, who received his PhD from New York University in 1968, teaches Portuguese and Brazilian History at the University of California, Santa Barbara. He has published widely on Colonial Brazil in the sixteenth and seventeenth centuries and on the role of the military orders of Christ, Santiago and Avis in Portugal and the Portuguese world, 1500-1777. He is currently completing a study of the Portuguese Order of Santiago, 1470-1578. JOSÉ EISENBERG is Professor of Political Science at the Instituto Universitário de Pesquisas do Rio de Janeiro (IUPERJ), and author of *As Missões Jesuíticas e o Pensamento Político Moderno* (Belo Horizonte: Ed. UFMG, 2000), and of "Cultural Encounters, Theoretical Adventures: The Jesuit Missions to the New World and the Justification of Voluntary Slavery," *Journal of the History of Political Thought*, forthcoming. His current research interests include early-modern and contemporary political theory.

MARÍA V. JORDÁN ARROYO studied at the Universidad de Puerto Rico and the University of Minnesota, where she received her MA and PhD degrees in Hispanic literature. She has concentrated her research on dreams and prophecies in the Hispanic world. ALCIR PÉCORA é Professor-associado, livre-docente, do Departamento de Teoria Literária da Unicamp. STUART B. SCHWARTZ is George Burton Adams Professor of History at Yale University where he teaches Latin American History, concentrating on Colonial Brazil. Educated at Middlebury College and Columbia University, he is the author of Sovereignty and Society in Colonial Brazil (1973), Sugor Plantations in the Formation of Brazilian Society (1985), Slaves, Peasants, and Rebels (1988), and Da América portuguesa ao Brasil (2003). MARIA BEATRIZ NIZZA DA SILVA received her PhD in Philosophy from the University of São Paulo in 1967.
